

Aotearoa New Zealand Sustainable Finance Taxonomy (NZ Taxonomy) Technical Expert Group (TEG) Terms of Reference

Aims and purpose

The Technical Expert Group (TEG) will oversee the development of the NZ Taxonomy. It will serve as an intermediary between the Technical Advisory Groups (TAGs) the lead agency, Ministry for the Environment (the Ministry), and the Government quality assurance function. The TEG offers strategic direction, input, and endorsement of all technical taxonomy methodologies and definitions, ensuring they align with Ministerial direction on taxonomy design and are fit-for-purpose for the Aotearoa New Zealand market. The TEG is made up of technical experts, subject matter experts and financial market participants.

The TEG will be established and convened by the Toitū Tahua: Centre for Sustainable Finance Trust (CSF), which will provide secretariat services to the TEG to enable it to fulfil its aims and purpose. The TEG's role is confined to the scope of work set out in this Terms of Reference, unless otherwise determined as a result of further decisions and agreements between the Ministry and CSF, or Ministerial decisions in future phases.

Scope of work

Outputs

- The primary output will consist of a final NZ Taxonomy document covering each sector prioritised for development in the 12 months commencing 1 November 2024.
- Key deliverables of the TEG, over the initial 12-month period, are:
 - Final taxonomy document for each prioritised sector, commencing with agriculture and forestry;
 - Technical documents on NZ Taxonomy methodologies and definitions, endorsed by the TEG in the form of written reports;
 - o 12 TEG meetings (see Appendix 1 for proposed meeting dates); and
 - Targeted engagement facilitated by CSF with interested and affected stakeholders on draft technical documents.

Role and remit of the TEG

TEG is a high-level decision-making body responsible for overseeing the NZ Taxonomy development to ensure usability and interoperability. The role of the TEG is:

- Responsible for the technical taxonomy documents;
- Provides endorsement of all technical taxonomy methodologies and definitions before they are provided to the Ministry and Government quality assurance function;
- Ensures technical components align with Ministerial direction on taxonomy design (principles, objectives, priorities etc.); and
- Provides strategic direction, reviews, inputs and provides final endorsement of outputs from the TAGs.

In addition, the TEG may advise the Ministry on other issues identified by the Ministry.



The TEG has a decision-making role regarding the NZ Taxonomy methodology and definitions, but it does not have formal decision-making power over its development process. It will feed into, but not replace, the Government's policy development process.

Approach to TEG convening and working

Term

Appointment to the TEG will be for an initial period of 12 months from the establishment of
the TEG, with the possibility of extension based on the needs and requirements of the NZ
Taxonomy project (e.g. for future phases of the Project and beyond). As part of the EOI
process led by CSF, conflicts of interest will be managed in accordance with the Ministry's
conflict of interest terms using the relevant form provided by the Ministry.

Frequency of meetings

- During the 12-month period, the TEG will meet 12 times. A minimum of 1 hour of preparation will be required for each of these meetings and TEG members will be required at a minimum of 9 meetings. Additional ad-hoc meetings may be convened if deemed necessary.
- The TEG will comprise a pool of experts, and different expertise will be required for different TEG meeting topics. Temporary TEG members will not be required to attend all TEG meetings.
- TEG meetings will be a combination of in-person and virtual meetings. Where meetings are in-person, a virtual option will be provided.

Confidentiality and transparency

- The day-to-day work and deliberations of the TEG should be respected as confidential to support open, high-trust debate within the group.
- Confidentiality agreements will be signed by participants and Chatham House rules apply to TEG conversations. An official record will be recorded in the meeting minutes. Meeting minutes will be made publicly available on the CSF website within 3 months of each meeting.
- TEG members are free to discuss their involvement in the TEG and share personal views on key issues, on the condition that anything shared by the Government with the TEG on a confidential basis is not disclosed publicly without express permission.
- Members are prohibited from making any public representations or opinions on behalf of the TEG, unless agreed in advance by the TEG members, CSF and the Ministry.
- Relevant Ministry representatives, members of the Government cross-agency taxonomy working group, and relevant Ministers and members of their offices will receive TEG progress updates provided by CSF.
- The list of members and observers, any additional TEG Terms of Reference and high-level minutes will be published on a dedicated webpage on CSF's website, in line with the current look, feel and functionality. This will be linked to the Ministry's website.
- CSF will not publicly attribute any specific advice to the TEG without first obtaining prior consent from the TEG members.

Membership

- The TEG is composed of a pool of up to 15 experts and market participants.
- CSF may seek to appoint additional temporary TEG members based on the needs of the work. Before appointing any temporary members, CSF will confirm the approach with the TEG and the Ministry.

Remuneration

Participation in the TEG is voluntary and unpaid.

Resignation

• Members may resign at any time on written notice to CSF. The confidentiality obligations of this Terms of Reference will continue to apply after resignation.

Role of CSF

CSF will:

- Be responsible for set up of independent advisory arrangements to develop the technical NZ Taxonomy documents;
- Convene, coordinate, manage and provide secretariat support to the TEG and TAGs;
- Facilitate stakeholder engagement and consultation; and
- Be accountable to the lead agency, the Ministry.

In carrying out its role, CSF will have due regard to the importance of safeguarding the independence and credibility of the NZ Taxonomy development process.
